

CONSENT AND RELEASE TO USE IMAGES AND WAIVER OF LIABILITY

For good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, I _____ [insert your name] (Releasor, "I," "me" or "my") grant to Canon U.S.A., Inc. ("CUSA"), and its designees, all worldwide rights in perpetuity in the photographic pictures, videographic tapings, audio recordings, footage, or other images of me, or in which I may appear (collectively, the "Images"), taken during the **Girls Inc. If I make any posts on my own hosted social media platform pages or websites (including, but not limited to, Facebook, Instagram and Twitter) related to the Event, I grant to CUSA and its designees the absolute right and permission to re-post, re-gram, and/or re-tweet such posts on its own hosted social media platform pages without first obtaining approval and without additional compensation to me.

I waive any right that I may have to inspect or approve the Images (edited and unedited) and any advertising copy or other matter that may be used in connection therewith and to the eventual use to which it may be applied. In the event that I receive any print, negative, or other copy of the Images, I shall not authorize its use by anyone other than myself and my current employer.

I release, discharge, and agree to hold harmless CUSA and its designees, and all persons acting under its permission or authority, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of such Images or in any subsequent processing or reproduction thereof, as well as any publication thereof.

In the event I have made statements containing or reflecting an endorsement of Canon products by me, CUSA and its designee will have the right to attribute the statement (or statements in different words which have substantially the same meaning) to me. Such endorsement represents my current honest opinions, findings, beliefs or experience. To the extent such endorsement suggests that I prefer the endorsed product(s) or service(s), I do in fact prefer them. To the extent that such endorsement suggests a comparison with other competing products or services, I have conducted such tests or other examinations of a fair and adequate sample of such competing products or services. I agree to immediately notify CUSA of any change in these views.

Further, I understand that, in connection with participating in the Event and any other activities associated with the Event, there is a chance that I may injure myself or damage my property, or that I may cause another individual to injure himself/herself or damage their property. I voluntarily assume all the risks of participating in the Event and will be solely responsible for my own actions. I release, discharge and agree to hold harmless CUSA and its affiliates and all persons acting under its permission or authority from and against any liability associated with the Event. I understand that all guests (including the guests' bags, equipment or other physical property) at this Event are subject to search, including screening with a metal detector before being admitted. By attending this Event, I consent to such a search. I also understand that this Consent and Release to Use Images and Waiver of Liability (the "Release") shall be construed broadly to provide a release and waiver to the maximum extent permissible under New York State law.

Nothing herein shall constitute any obligation on CUSA and its designees to make use of any of the rights set forth in this Release.

I hereby represent and warrant that I am of legal age and have the legal capacity to execute this Release and the right to contract in my own name. I agree that I shall have no claim to any additional compensation and no claim (including without limitation, claims based upon invasion of privacy, defamation or right of publicity) arising out of any use, alteration, distortion, or illusionary effect or use in any way of the Images by CUSA, and its designees, I have read this Release prior to its execution, and I am fully familiar with the contents hereof. This Release contains the entire understanding between me and CUSA, there being no prior written or oral promises or representations not incorporated herein. This Release may not be modified except by a writing executed by me and CUSA. The transmittal of a fully-executed original of this Release electronically or by facsimile machine will constitute good and valid execution of this

Release and will be legally binding on the parties.

If any provision of this Consent, Release and Waiver of Liability or the application thereof is held invalid by a court of law, the invalid provision shall not affect any other provision or the application thereof which can be given effect without the invalid provision or application, and to this end the provisions of this Release are declared to be severable.

This Release shall be binding upon me, my heirs, legal representatives, and assigns.
